

The Turner County Board of Commissioners met on Thursday, June 27, 2013 at 6:00 P.M. in a called (advertised) meeting with for adoption of the budget for FY 2013-2014 at the Turner County Courthouse Annex Building with Commissioners Calhoun, Hall, Hudgins and McCard present. Commissioner Burgess was not present for the meeting. Staff present were Mary J. Wynn, Manager and Latrice Wilson, Clerk.

Chairman McCard called the meeting to order at 6:00 P.M.

Commissioner Calhoun gave the invocation.

Motion by Calhoun seconded by Hall to adopt Budget Resolution # 2013-06-01 approving FY 2013-2014 budgets as follows: General Fund -\$6,743,000.00; Special Purpose Local Option Sales Tax Fund (2006 Issue) - \$370,100.00; Special Purpose Local Option Sales Tax Fund (2012 Issue) - \$900,100.00; Jail Special Revenue Fund - \$151,200.00; Drug Education Special Revenue Fund - \$26,020.00; Hotel/Motel Tax Special Revenue Fund - \$2,005.00; E-911 Special Revenue Fund - \$504,700.00; Sheriff Drug Enforcement Special Revenue Fund - \$25,020.00; Real Estate Deed Index Special Revenue Fund - \$17,550.00; Victims Assistance Special Revenue Fund - \$651,000.00; Solid Waste (Deposit) Special Revenue Fund - \$10,000.00; Solid Waste Special Revenue Fund - \$225,000.00; CHIP Housing Grant Fund - \$40,000.00; Drug Task Force Fund - \$60,900.00; Capital Improvement Budget - \$300,000.00 and authorize Chairman McCard to sign Budget Resolution on behalf of the County.
