

Turner County Board of Commissioners met on Tuesday, August 4, 2015 at 6:00 P.M. at the Turner County Agricultural Center for the monthly regular meeting with Commissioners Burgess, Calhoun, Denham, Hall and McCard present for the meeting. Staff present were Latrice Wilson, County Clerk and John Holland, County Attorney. Motion by Commissioner Hall seconded by Commissioner Burgess to approve project list for the FY 2016 Local Management & Improvement Grant (LMIG) Program. Youngblood Road and Industrial Boulevard are the two roads that were approved for leveling and resurfacing, motion passed with Commissioners Burgess, Calhoun, Denham, Hall and McCard voting in favor of the motion.

Motion by Commissioner Burgess seconded by Commissioner Calhoun to reappoint the following board members to serve on the Airport Authority Board: Scotty Wilkerson, Ross Kendrick, Jay Leatherwood, Eric Richter and Mike Mastrario for a one year term effective July 1, 2015 ending June 30, 2016, motion passed with Commissioners Burgess, Calhoun, Denham, Hall and McCard voting in favor of the motion.

Motion by Commissioner Denham seconded by Commissioner Burgess to accept bids from Flint Company for John Deere equipment for the Road Department, motion passed with Commissioners Burgess, Calhoun, Denham, Hall and McCard voting in favor of the motion.
