Commissioners discussed Wine and Liquor License for Ashburn Golf & RV LLC and decided to discuss at a later date due the request of liquor by the drink which requires a referendum before approval.

Motion by Commissioner Whiddon seconded by Commissioner Burgess to allow the Sheriff to apply for a grant for remote site, motion passed with Commissioners Burgess, Calhoun, Denham, Weaver and Whiddon voting in favor of the motion.
