Chairman Denham called the meeting to order at 6:00 p.m., Mr. Ben Baker gave the invocation followed by the pledge of allegiance.

Motion by Commissioner Calhoun seconded by Commissioner Whiddon to accept bid from Griffin Grading & Concrete LLC in the amount of \$474,250.68 for the 2024 LMIG for widening, leveling, and resurfacing improvements to Denham Road, motion passed with Commissioners Burgess, Calhoun, Weaver and Whiddon voting in favor of the motion. Commissioner Denham opposed the motion.

Motion by Commissioner Whiddon seconded by Commissioner Burgess to approve fees for Turner County Health Department as presented, motion passed with Commissioners Burgess, Calhoun, Denham, Weaver and Whiddon voting in favor of the motion.

Motion by Commissioner Calhoun seconded by Commissioner Burgess to accept bid from Flint Equipment Company to purchase a 2023 John Deere FC15M Flex Wing Rotary Cutter in the amount of \$23,500.00 for Public Works, motion passed with Commissioners Burgess, Calhoun, Denham, Weaver and Whiddon voting in favor of the motion.

Motion by Commissioner Burgess seconded by Commissioner Weaver to approve purchase of a 2024 Kubota L2502DT Tractor 4x4, value \$18,200, 2024 Kubota LA526 loader bucket, value \$6,300, and 2024 Land pride finish mower, value \$3,500 from Perrin Farm Equipment for Turner County Parks & Recreation, motion passed with Commissioners Burgess, Denham, Weaver and Whiddon voting in favor of the motion. Commissioner Calhoun opposed the motion.

Motion by Commissioner Calhoun seconded by Commissioner Burgess to approve Executive Minutes for Tuesday, February 6, 2024 and Tuesday, February 27, 2024 as printed, motion passed with Commissioners Burgess, Calhoun, Denham, Weaver and Whiddon voting in favor of the motion.

Mr. Jim Lumpkin, Coroner, gave an update on the call volume and transporting expenses for the Coroner's Office.

Motion by Commissioner Calhoun seconded by Commissioner Burgess to end the closed session and return to the regular meeting at 6:48 p.m., motion passed with Commissioners Burgess, Calhoun, Denham, Weaver and Whiddon voting in favor of the motion.

Motion by Commissioner Calhoun seconded by Commissioner Weaver to not renew County Manager, Cherysh Green-Caldwell employment contract and to pay Mrs. Caldwell from March 11, 2024 through March 31, 2024 plus an additional three months of salary and benefits as stated in the employment agreement, motion passed with Commissioners Calhoun, Denham and Weaver voting in favor of the motion. Commissioners Burgess and Whiddon opposed the motion.
